## CONSENT AND RELEASE

2. # MALTESAS COPYRIGHT FORM *(continued)*

## RETAINED RIGHTS/TERMS AND CONDITIONS

### General

1. Authors/employers retain all proprietary rights in any process, procedure, or article of manufacture described in the Work.
2. Authors/employers may reproduce or authorize others to reproduce the Work, material extracted verbatim from the Work, or derivative works for the author's personal use or for company use, provided that the source and the MALTESAS copyright notice are indicated, the copies are not used in any way that implies MALTESAS endorsement of a product or service of any employer, and the copies themselves are not offered for sale.
3. Although authors are permitted to re-use all or portions of the Work in other works, this does not include granting third-party requests for reprinting, republishing, or other types of re-use. The MALTESAS Intellectual Property Rights office must handle all such third-party requests.
4. Authors whose work was performed under a grant from a government funding agency are free to fulfill any deposit mandates from that funding agency.

### Author Online Use

**5. **6. **7. (1) the full citation to the MALTESAS work with a Digital Object Identifier (DOI) or link to the article abstract in MALTESAS Xplore, or (2) the accepted version only (not the MALTESAS-published version), including the MALTESAS copyright notice and full citation, with a link to the final, published article in MALTESAS Xplore.

## INFORMATION FOR AUTHORS

### Author Responsibilities

The MALTESAS distributes its technical publications throughout the world and wants to ensure that the material submitted to its publications is properly available to the readership of those publications.
